

**RIDE FOR THE HEROES WAIVER AND RELEASE FORM**  
**READ THIS DOCUMENT, YOU ARE GIVING UP RIGHTS.**

**By signing this document, you agree that you have read and understood its contents  
and agree to be bound by its contents.**

I, the undersigned, on my own behalf and on behalf of my heirs, personal representatives, successors and assigns, for and in consideration of the opportunity to participate in a Motorcycle Ride, known as "The Ride For The Heroes", an event sponsored and conducted by the Central Bucks Rotary, a non-profit entity; hereby agree to release and forever hold harmless the Central Bucks Rotary, its servants, agents, employees, directors, attorneys and assigns (the "Released Parties"), from any and all claims, rights and/or causes of action whatsoever which I may now have or may ever have in the future that arise in any way out of or in connection with the event known as "The Ride For The Heroes".

This Release and Hold Harmless extends to any and all claims I have or may have against the Released Parties resulting from or arising out of their action, inactions and/or performance of their duties in conducting this event, whether or not such claims are a result of the negligence of the Release Party with respect to the conditions, qualifications, instructions, rules or procedures under which this event is conducted or for any other matters surrounding this event. I understand that I am covenanting not to sue or bring any cause of action whatsoever against the Released Parties for any injury sustained by myself or to my property arising from, or in connection with the performance of their duties in conducting this event. This provision shall survive execution and termination of this agreement and shall enure to the benefit of the Released Parties.

I also hereby certify that I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in this event and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I or my passenger(s) may sustain to my person and/or property as a result of my participation in the event, and any negligence on the part of any of the Released Parties in performing their duties in conducting this event.

As you will be riding on public highways, you will be responsible to determine the speed and operation of your motorcycle. You will be required to observe all state, federal and local laws while participating in this ride and will be required to ride safely and defensively. You are required to ride wearing a helmet, appropriate clothing and eyewear. If you and/or your passenger choose to ride without a helmet or other appropriate apparel, you do so at your own risk. You are required to ride with your headlight on at all times while participating in the ride.

You hereby certify that you have no known physical or mental impairments that may affect your safety or the safety of the group. You certify that you are not under the influence of any drugs, alcohol or medications which would impair your ability to participate in the ride in a safe manner. You also certify that you are a licensed motorcycle operator in good standing and are familiar with the operation of motorcycles and fully understand the risks and dangers inherent to motorcycling.
